



## **Tesla Model 3 Incentive Terms and Conditions**

### **Award Details and Criteria**

The first **100** Tesla Model 3 owners who apply via the provided link will each be given a \$500 incentive award with only **1** incentive award per person.

As noted on the form provided by Driving-Tests.org [here](#), each applicant must provide proof of purchase of the Tesla Model 3 vehicle and proof (a short video link) that his or her child practiced driving the Tesla, even if only for a short few minutes at slow speeds around an empty parking lot.

Each winning entrant must reside in the United States or Canada and must complete the entirety of the form provided by Driving-Tests.org.

### **Winner Notification and Verification**

Each potential winning Entrant will be notified via the email address provided with his or her submission. Each potential winning Entrant must provide to Driving-Tests.org within five (5) business days after the date of receipt or other date specified by Driving-Tests.org (i) the winner's address, and (ii) the necessary information to send payment by check. If any potential winner (i) cannot be reached or does not respond to notification within forty-eight (48) hours, (ii) fails to return the necessary information within the designated period, or (iii) does not comply with these Official Rules, that potential winner may be disqualified at the sole discretion of Driving-Tests.org and forfeit the prize. If a potential winner is disqualified for any reason, Driving-Tests.org will choose the next entrant.
